Michael Seng is the co-executive director of The John Marshall Law School Fair Housing Legal Support Center and Fair Housing Legal Clinic. He lectures nationally and publishes extensively on fair housing law.

Professor Seng also is the coordinator of The John Marshall Law School's Czech law program. He travels annually to the Czech Republic to teach and publishes articles, in English and Czech, in Czech law journals.

Prior to joining the John Marshall faculty, Professor Seng served as a judicial law clerk, was in private practice, and directed the legal services office in Cairo, Illinois. Professor Seng served as a Fulbright professor in Nigeria in 1983-84 and as a visiting professor in the Czech Republic in 1996. He writes on civil rights issues.

Professor Seng joined the faculty in 1976. He teaches Comparative Legal Systems, Constitutional Law, and Federal Courts.

1976 - Present

In addition to teaching, he has served as counsel in a number of cases in the state and federal courts. Most of these cases have involved constitutional or public law issues, including a number of civil rights cases. Co-counsel in a suit attacking the Illinois Residential Picketing Statute as violative of the First Amendment, Carey v. Brown, 447 U.S. 455 (1980), and in an appeal to the Supreme Court on the validity of a referendum under the Equal Protection Clause, City of Cuyahoga Falls v. Buckeye Community Hope Foundation (2003), and in Voting Rights Act suits against the Cook County judiciary and the City of Chicago Heights, Illinois.
